CUSTOMS GENERAL ORDER No. 08/2009

SUBJECT: -- PROCEDURE FOR THE CLEARANCE OF GROUND HANDLING EQUIPMENT WITHIN THE JURISDICTION OF CUSTOMS AIR PORT IN PAKISTAN.

The following procedure shall be observed for the clearance of Ground Handling Equipment named in the appended list and imported by various Airlines/Ground Handling Service providers for use in connection with the maintenance and establishment of International Service and which are exempt from duty and taxes. In order to avoid abuse of the concession, the exemption shall be confined to such equipment as are used within the notified customs area of airports in Pakistan.

- 2. A list of such Equipment will be furnished by the Air Lines/Ground Handlers to the Collector of Customs at the time of importation with a guarantee that the Equipment will be used only within the limits of the airport in connection with their airport services. The Air Lines/Ground Handlers shall also enter into an Indemnity Bond, or submit any other financial instrument) binding themselves that the Ground Equipment imported by them shall be used within the limits of Air Port in the notified area and when any of the imported equipment is no longer required it will be re-exported out of the country. If the Air Lines/Ground Handlers intend to dispose of the equipment locally, they should obtain prior permission from the Board to do so. In such cases the equipment should be re-valued and duty and sales tax and other taxes realized.
- 3. All imports of Ground Equipment by air or sea will be noted in a register on the enclosed format maintained for this purpose in the Air Freight Unit. The serial number of the entry in the register will be allotted on the Goods Declaration and to the ground equipment under the serial as General Equipment List "G.E.L" The serial number will be painted or otherwise executed by the Air Line; Ground Handler on the equipment in question and will be an authority for the use of the equipment. This will facilitate the physical check of the ground equipment imported by the airline. A separate format will be maintained for each Air Line Ground handler.
- 4. This Indemnity Bond will be renewed each fiscal year. While applying for the renewal of the Bond, the Air Line/Ground Handler will furnish a complete list of ground equipment held by them upto date and after physical check up and accounting for re-export or local disposal. The bond will be renewed for another year pertaining to equipment already imported or disposed of locally.
- 5. Ground Handling Service Providers/Ground Handlers is to whom a licence has been issued by the Civil Aviation Authority for such purposes.
- 6. Each Ground Handling Service providers/Ground Handler shall develop software and establish an online connection with the Customs authorities for regulating imports/disposal under this CGO.
- 7. This Customs General Order supersedes Standing Order No.39/66 dated 5th July. 1966 and all other instructions issued by the Board from time to time.
