<u>DETERMINATION OF CUSTOMS VALUES OF CERAMIC & PORCELAIN TILES</u> UNDER SECTION 25-A OF CUSTOMS ACT, 1969

(VALUATION RULING No. 1787/2023)

C. No. Misc/12/2010-V/589

Dated: 09th June, 2023

In exercise of the powers conferred under Section 25A of the Customs Act, 1969, Customs values of Ceramic & Porcelain Tiles are determined as follows:

- **2. Background of the valuation issue:** Earlier, the Customs values of Ceramic and Porcelain Tiles were determined under Section 25-A of the Customs Act, 1969, vide Valuation Ruling No.874/2016, dated 22-06-2016, that was challenged before the Director General under Section 25D of the Customs Act, 1969 and was upheld vide Order in Revision No. 225/2016 dated 04.08.2016 with the instruction that the **"prices of Chinese origin tiles shall be enhanced by 12.50% with immediate effect".** As considerable time has passed since issuance of the afore-referred Valuation Ruling, an exercise for the re-determination of Customs Values of the same has been undertaken by this Directorate.
- **3. Stakeholders' participation in determination of Customs values:** Meetings were convened on 02.03.2022. 21.07.2022, and 20.12.2022 which were attended by the relevant stakeholders. The issues pertaining to the valuation of subject goods were deliberated upon in detail in the afore-referred meetings.
- 4. Analysis / Exercise done to determine Customs Values: The importers informed that the customs values in the existing Valuation Ruling are on a higher side, which may be rationalized considering the worldwide recession and existing freights which have decreased substantially. Further, they added that duty and taxes on the subject goods have also been increased that is adversely affecting the trade. In this regard, recent import data and market prices of the subject goods have been scrutinized in terms of Section 25 (7) of the Customs Act, 1969 to arrive at the Customs Values of Ceramic and Porcelain Tiles. However, no documentary evidence was furnished by the Stakeholders / importers and market inquiry conducted in this regard was found to be contrary to the fact of recession being quoted by them.
- 5. Method (s) adopted to determine Customs values: Valuation methods specified in section 25 of the Customs Act, 1969, were duly applied in sequential order to arrive at the Customs value of subject goods. The transaction value method as provided in sub-section (1) of section 25 of the Customs Act, 1969, was found inapplicable due to wide variation of values in import data. Moreover, the requisite information under law was not available to arrive transaction value. Therefore, identical/similar goods value methods provided in Section 25(5) & 25(6) were examined for applicability to determine customs value of subject goods. The data provided much reference; however, it was found that the same could not be solely relied upon due to absence of absolute demonstrable evidences of quantities and qualities, variation in declaration, variety and specifications. Information available was, hence, found inapplicable. In line with statutory sequential order of Section 25 of the Customs Act, 1969, this Directorate conducted market survey under sub-Section (7) of Section 25 of the Customs Act, 1969. Finally, Customs Values of Ceramic and Porcelain Tiles have been determined under Section 25(7) of the Customs Act 1969.

6. Customs values for Ceramic & Porcelain Tiles: *hereinafter specified* shall be assessed to duty/ taxes on the Customs values given against them in the Table below:-

^{7.} In cases, where declared values are higher than the Customs values determined in this Ruling, the assessing officers shall apply those values in terms of sub-section (1) of Section 25 of the Customs Act, 1969. In case of consignments imported by air, the assessing officers shall take into account the difference between air freight and sea freight while applying the Customs values in this Ruling.

^{8.} Validity, of this Valuation Ruling: This Ruling, containing the Customs values for assessment of subject imported goods, shall be applicable until and unless the same, are rescinded or

revised by the competent authority in terms of sub-section (4) of Section 25A of the Customs Act, 1969.

- **9. Revision of the values determined vide this Valuation Ruling:** If aggrieved, a revision petition may be filed against this ruling as provided under Section 25D of the Customs Act, 1969, within 30 days from the date of its issuance, before the Director General, Directorate General of Customs Valuation, 7th Floor, Custom House, Karachi.
- 10. The Collectors of Customs may kindly ensure that the values given in the Valuation Ruling, for the given description of goods, are applied by the concerning assessing officers / officials without fail. Any anomaly observed may kindly be brought to the notice of this Directorate immediately. The Customs values determined in the ruling are for the descriptions and specifications as mentioned in the aforementioned table in this Ruling. HS Codes are mentioned for illustrative purposes so that Valuation Ruling values are made accessible to the assessing officers. The assessments shall be finalized on the basis of correct classifications after fulfilling all formalities related to importability or other certifications required thereon.
- 10. This Ruling supersedes Valuation Ruling No. 874/2016 dated 22-06-2026 and its Order-in-Revision No. 225/2016 dated 04-08-2016.
